Sir/Madam,

In terms of Section 14 of the NCTE Act, 1993, the Secretary had submitted an application (Code No. APE00944) to the ERC for grant of recognition for conducting B.T.C. (PTTC) Course of two years duration with an annual intake of 50 students at Dr. Ambedkar Hindi Sanskrit Vidyapeeth Bihar Cum Education & Training, VIII - Jokia, Po - Joika, Dist - Begusarai, Bihar - 851127.

On the basis of scrutiny of the documents submitted by the institution the documents attached therewith, input received from the Visiting Team Report and videography alongwith related documents, the ERC in 103rd meeting held on 29-31 December, 2009 is satisfied that the above institution has adequate financial resources, accommodation, library, laboratory as prescribed in the norms and standards and that it fulfills all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course.

Before grant of formal permission under Regulation 7(1) is considered, you are requested to submit the following:-

- (i) The institution shall make appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. The institution may submit countersigned statement of staff appointed as per the NCTE norms as per approval of the concerned affiliating body.

- (ii) An Affidavit on Rs. 100/- Non-Judicial stamp paper by the Applicant is required to be submitted alongwith individual affidavits on Rs.10/- Non-Judicial stamp paper as per the prescribed format to be submitted by the academic staff duly selected and appointed.
- (iii) The institution shall launch its website covering, *inter alia*, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms, and other facilities/amenities), instructional facilities (laboratory, library, etc.) and the particulars of their proposed teaching and non-teaching staff etc. with photographs. The downloaded copies of the website is required to be submitted

4. Admission should not be made until formal permission order under Para 7(11) of the NCTE (Recognition Norms & Procedure) Regulations, 2007 is issued by the Eastern Regional Committee, NCTE and affiliation is obtained from the University/ examining body concerned.

5. You are advised to comply the above requirement before formal permission is considered under Regulation 7(11). The reply along with supporting relevant documents may be sent to ERC, NCTE, within 30 days of the issue of this letter.

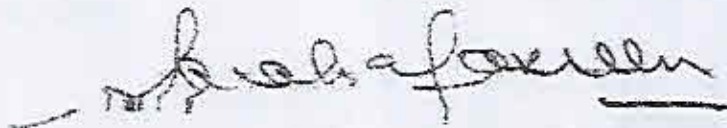

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Dr. Ambedkar Hindi Sanskrit Vidyapeeth Bihar Cum Education & Training, Vill - Jokia, Po - Joika, Dist - Begusarai, Bihar - 851127 has submitted an application (Code No.APE00944) to the Eastern Regional Committee of NCTE for grant of recognition for conducting BTC (D.Ed.) Course of two year duration with an annual intake of 50 (fifty) students on dt.16.04.2008.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Elementary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Dr. Ambedkar Hindi Sanskrit Vidyapeeth Bihar Cum Education & Training, Vill - Jokia, Po - Joika, Dist - Begusarai, Bihar - 851127 for conducting BTC (D.Ed.) Course of Elementary level of two years duration with an annual intake of 50 (fifty) students from the academic session 2009-2010 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject to fulfilment of the following conditions:

- (i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010 failing which the recognition will be effective from the academic session 2010-2011 only.
- (ii) Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days the session is fulfilled as per the calendar of the University/Affiliating Body.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Eastern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) ✓ The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE [Recognition Norms & Procedure] Regulations, 2007.
- (vi) The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

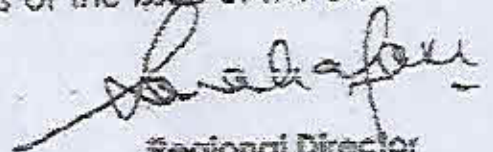

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.

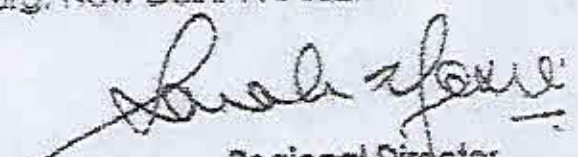
